

## YMCA 'REFER A FRIEND' PROMOTION - TERMS AND CONDITIONS (Terms)

### 1. OFFER AND ELIGIBILITY

- a. This 'Refer A Friend Promotion' (**Promotion**) is offered by Victorian YMCA Community Programming Pty Ltd (ABN 75 092 818 445) of 502/990 Whitehorse Rd, Box Hill VIC 3128 (**YMCA**).
- b. By participating in the Promotion, you agree to be bound by these Terms.
- c. The Promotion is available at Ashburton Pool and Recreation Centre, Hawthorn Aquatic and Leisure Centre, Warragul Leisure Centre, South Gippsland SPLASH, Peter Krenz Leisure Centre, Benalla Aquatic Centre, Numurkah Aquatic and Fitness Centre, Coburg Leisure Centre, Brunswick Baths, Fawkner Leisure Centre, Horsham Aquatic Centre, Gippsland Regional Aquatic Centre (**Participating Centres**) between the dates and times of 06:00am on 10 June to 11:59pm on 7 July 2025 (**Promotion Period**).
- d. To be eligible for the Promotion:
  - i. You must be an existing member at the relevant Participating Centre, and the friend you are referring must not already be a member at that Participating Centre;
  - ii. Your friend must become a member at that Participating Centre within the Promotion Period.
- e. The Promotion is not valid in conjunction with other offers, unless approved in writing by YMCA.

### 2. SIGN UP TERMS

- a. If you meet the criteria set out in clause 1(d), we will give you one free swimming lesson from your existing membership for up to a maximum of four referrals.
- b. This offer can only be used for one family member if you have multiple family members with swimming memberships.
- c. The Promotion is only available at Participating Centres.
- d. The Promotion is available for Y swimming lessons not for school groups or holiday programs. It is available for infants, pre-school, primary school aged programs and teens etc (exclude schools and school holiday programs).

### **3. PRIVACY**

### **4. MISCELLANEOUS**

- c. Any dispute or situation not covered by these terms, will be resolved by YMCA management in a manner it deems to be fair (acting reasonably).
- d. These Terms are governed by the laws of Victoria, Australia.
- e. Members will be bound by their terms of membership with YMCA. To the extent of any inconsistency between the terms of membership and these Terms, these Terms will take priority.
